# Halal: Allowed and Suggested

#### Definition

Halal means any approved and more especially encouraged action in Islam. Halal means an opposite of Haram that has things which should not be done. Halal is a multidimensional concept comprising of food, behaviour and business.<sup>2</sup>

#### **Behavior**

Halal also cover behavior and actions. Muslims are advised to be morally correct and adhere to Islamic teachings. That includes being truthful, kind, and courteous to others. It is acting in ways that are not bad or maintaining moral convictions. Giving up on lying, stealing, and cheating, for example.

#### Food

When discussing Islamic culture and eating customs, the word "halal food" is frequently used. Knowing what it implies and how it affects the food we consume might be difficult to grasp. Food that complies with Islamic dietary regulations and is thus acceptable for Muslims to consume is referred to as halal food. The fundamental tenets of halal eating include avoiding some meats, making sure animals are slaughtered according to rules, and staying away from specified components. The Holy Quran says that: "O mankind, eat from whatever is on earth [that is] lawful and good and do not follow the footsteps of Satan. Indeed, he is to you a clear enemy".<sup>3</sup>

It's critical to comprehend halal food in order to promote inclusivity and accommodate dietary restrictions in different cultures. Since halal food is a basic component of the dietary regulations that regulate the amount of food Muslims can consume, it holds great significance in Islamic culture. Muslims are only permitted to eat halal food that has been cooked in accordance with strict guidelines to guarantee food safety. This is in accordance with Islamic dietary requirements.<sup>4</sup> Islamic culture places a high value on halal cuisine since the Quran emphasises that Muslims should only eat clean, healthful food. A number of meals, like as pork and carrion, are forbidden by the Quran, which also emphasises the need of consuming only halal and tayyib cuisine.<sup>5</sup> Allah (SWT) says that "They ask you, [O Muhammad], what has been made lawful for them. Say, "Lawful for you are [all] good foods and [game caught by]

what you have trained of hunting animals which you train as Allah has taught you. So eat of what they catch for you, and mention the name of Allah upon it, and fear Allah." Indeed, Allah is swift in account". <sup>6</sup> Another place Allah (SWT) said, "O messengers, eat from the good foods and work righteousness. Indeed, I, of what you do, am knowing. <sup>7</sup>A crucial component of producing and distributing halal food is halal food certification. The certification procedure guarantees that the food satisfies the standards outlined in Islamic dietary regulations and is suitable for Muslim eating. <sup>8</sup>In order to obtain certification, the entire food manufacturing process must be inspected to make sure that it adheres to the halal requirements outlined by

Islamic dietary laws, from the procurement of components to the finished product.<sup>9</sup>
